MINUTES OF A REGULAR MEETING OF THE REDEVELOPMENT COMMISSION

A meeting of the Munster Redevelopment Commission convened at 7:05 p.m. on Monday, May 5, 2025. Ordinance 1830 is the basis for holding electronic meetings.
