As we power through another lovely Region winter, many in Town are looking towards the future. This includes the developers of Maple Leaf Crossing and the Lansing Country Club. You may have noticed the heavy equipment at the Maple Leaf site which was installing the underground infrastructure for their development. With the recent approval of their final plat, Maple Leaf is well-positioned to begin construction on buildings when the weather is cooperative.

The sale of the Lansing Country Club to the Saxon Partners closed in January. Some folk may not realize that about 85 acres of the Club sit in Indiana. This project is still in its infancy and has yet to come before the Plan Commission or any other Town body for a formal hearing. When there is more information, we will have a place on our website that you can refer to for documents, plans, etc.

We will also be doing some of our own construction, as well. The Town was recently awarded a matching grant of nearly \$475,000 from the State of Indiana for local street improvements. With these funds, residents on Elliott between Columbia and White Oak, Timrick between Forest and Fisher, Crestwood between Azalea and Bluebird, and Bluebird between White Oak and Foliage will see their streets resurfaced.

Additionally, the Town was awarded a \$25,000 matching grant to beautify the landscape along the newly installed bike path that runs from Calumet Avenue along the Canadian National rail line to the pedestrian overpass. This work will commence in the spring, as well.

Also coming in the future is a potential change in our residential trash and recycling hauler. Our current contract with Waste Management expires in March and we will be going out to bid for this service in February.

Tips for Sharing the Road with Snow Plow Drivers

- Visibility Take precautions to see, be seen, and stay out of the snow cloud of the plow
- Distance Stay a safe distance away from plows and give them room to operate
- Passing Only pass when necessary and never pass on the
- Speed Slow down and remember that snow plows operate
- Echelon Plowing Take special care and never pass plows working in tandem
- Trucks release salt and sand from the back of the truck if you're too close to the truck, materials could hit your windshield and obstruct visibility.
- A snowplow operator's field of vision is restricted. You may see them, but they may not be able to see you.
- Snowplows turn and exit the road frequently, give them plenty of room to maneuver.
- Don't travel next to a plow, if possible. When plowing through a snowdrift or packed snow, the impact can move the truck sideways.
- REMEMBER ICE & SNOW TAKE IT SLOW!

MUNSTER POLICE HONORED FOR TOP NATIONAL NIGHT OUT EVENT IN 2020

The Munster Police Department and Choice Community Council were notified in December that Munster's 25th Annual National Night Out Against Crime Celebration, which was held on October 6, 2020, was ranked by the National Association of Town Watch as the #1 National Night Out event in the United States among communities with populations in between 15,000-50,000 people. Munster was awarded with the National Night Out Cup (pictured) by the National Association of Town Watch in January.

The National Night Out is celebrated in hundreds of communities throughout the United States each year in an effort to promote positive police and community partnerships through a variety of both fun and educational activities for the public.

The National Night Out is usually held each August as a centralized event at the Munster Community Pool and includes swimming, games, prizes, fireworks, booth participants, safety demonstrations, a community parade, and more, however, due to the current health situation this year's event was organized with different activities so that it could be celebrated by our community in a safe way.

This year's event included three separate neighborhood parades of emergency vehicles, safety mascots, volunteers tossing out giveaway items to children (while wearing masks and gloves), and Citizenship Award winners. Residents were able to watch the parades from the safety of their front yards and were also provided online with Resident Safety Guides with tips to share with their families that day. Area businesses were also provided with Business Safety Guides to share with their staff members and employees.

In addition, a local Girl Scouts Troop raised funds to purchase hundreds of police support signs which residents picked up from the station to hold or display in their windows during the parades, and blue glow necklaces were also made available at the police station for children to wear that day. Members of the community were also encouraged to display blue lights to show their support for the event, and a canned food drive at the station collected hundreds of items that were later transported by the police department to a local food pantry.

SNOW REMOVAL ORDINANCES

Please read and remember the Town of Munster's ordinances for snow removal.

Ordinance:

It is hereby declared and proclaimed that it is necessary to the public health and safety that the streets of the town be cleared of snow, and if the clearing of snow is impeded and delayed by vehicles parked on the streets, such impediment and delay is detrimental to the public health and safety.

Whenever there has been snow of two inches or more, in order not to delay the clearing of such streets, all vehicles parked on all streets of the town, except streets in the area bounded by, but not including, Manor, Hohman, Ridge Road, and the northern town limits, shall be removed by the owner. These are the one-way streets between Manor and Ridge Road in the northwest section of town.

If such vehicles are not removed from the streets after two inches of snowfall occurs, and after ticketing, it shall be the duty of the police department of the town to forthwith employ some reputable person to remove such vehicles from the streets.

Ordinance:

The owner and/or occupant of any dwelling, building or subdivided lot or property shall keep the sidewalks in front thereof clean at all times of the year. Within 24 hours after any fall of snow or formation of ice, such snow or ice shall be removed from the sidewalks.

It shall be unlawful for any person to throw, push or deposit in any manner snow, slush or ice onto any street or sidewalk in such a manner as to impede the safe progress and movement of vehicular or pedestrian traffic.

Persons who violate this subsection are responsible for the costs incurred by the town to remove the impediment to safe progress and movement of vehicular and pedestrian traffic.

If you believe that a residence or business is not following this ordinance, please contact either the Munster Police Department by calling 911 or you can report the matter to Community Service Officer Kim Nordhoff at 219-836-6659 for follow-up. If the situation is an extreme safety concern, always call 911.



Electronic Recycling

Waste Management does not pick-up electronics or televisions. Electronics such as personal computers, laptops, printers, cell phones, DVD players and televisions can be brought to the electronic recycling shed located at 508 Fisher Street. The recycling shed

is located outside of the gates at the Public Works facility, so it is always open. Your electronic items can be dropped off at any time because there is not an attendant. Electronic Recycling is available for Lake County residents only and not for non-profits, businesses or schools use.

Winter Fire Safety **Keep Fire Hydrants Free of Snow**

In an emergency, every second matters. Fire hydrants that are blocked, concealed or difficult to access due to snow or ice can impede emergency fire response. Snow-covered hydrants can delay fire services, costing crucial seconds or minutes that can mean the difference between saving a structure and its inhabitants and not doing so.

- Consider enlisting others to assist in snow removal around fire hydrants and storm water grates.
- Clear snow and ice from fire hydrants in your area three feet on each side.
- Shovel path from the street or driveway to the fire hydrant so that it is visible from the road and firefighters can easily gain **
