Re: Ordinance 1648, Additional Appropriations (4)

Ordinance 1648 was introduced at the November 10, 2014, meeting and had first reading. Additional appropriations are being sought in the Major Moves Fund 450 and the County Economic Development Income Tax Fund (CEDIT) 209.

The procedure for securing the additional appropriations requires a public hearing, scheduled for this evening, and the adoption of an ordinance by the Town Council. Upon passage of the ordinance, the additional appropriations will be forwarded to the DLGF for approval. The DLGF is required to issue a determination within fifteen days of receiving the request for additional appropriations for funds subject to their approval.

The additional appropriations are supported by revenues and reimbursements from the State of Indiana.

RECOMMENDED ACTION:

Conduct a public hearing on the proposed additional appropriations. By motion and roll-call vote, approve introduced Ordinance 1648 as presented.

ORDINANCE 1648

**AN ORDINANCE FOR THE ADDITIONAL APPROPRIATION OF
FUNDS FOR THE YEAR 2014 (4)**

WHEREAS, The use and expenditure of money is required to carry on necessary governmental functions; and

WHEREAS, The amount of money to carry on necessary governmental functions is prescribed in the budget for the year 2014 as should be determined by the Department of Local Government Finance through their budget order; and

WHEREAS, The Town Council of the Town of Munster, Lake County, Indiana, now finds it necessary to appropriate more money than the amount anticipated to be prescribed in the budget for the year 2014; and

WHEREAS, There are sufficient funds available for additional appropriation; now, therefore, be it

ORDAINED, By the Town Council of the Town of Munster, Lake County, Indiana, that for the expenses of the taxing unit, the additional sums of money are hereby appropriated out of the funds named in the attached Certified Copy of Additional Appropriations and the attached Appropriations Certificate, subject to laws governing the same:

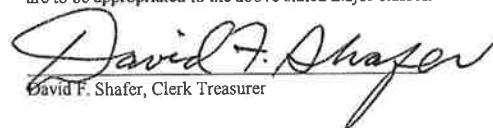
