**TOWN OF MUNSTER
MINUTES OF A SPECIAL MEETING OF THE TOWN COUNCIL
MAY 26, 2015**

A special meeting of the Munster Town Council convened at 7:00 p.m. on Tuesday, May 26, 2015, at the Munster Town Hall. Town Councilors Andy Koultourides, David B. Nellans, and Joseph A. Simonetto were present. Councilors John W. Edington and John P. Reed were absent. President Koultourides presided. Also present were Clerk-Treasurer David F. Shafer, Town Manager Dustin Anderson, and Town Attorney Eugene M. Feingold. The news media were represented by Devin Shinkle of *Northwest Indiana News Bureau*, an online news service.

President Koultourides opened the meeting with a moment of silence followed by the Pledge of Allegiance.
