A RESOLUTION AMENDING AND RESTATING THE DEFERRED COMPENSATION PLAN

WHEREAS, The Town of Munster has established a deferred compensation plan through ICMA-RC to provide reasonable retirement security for its employees and officers; and

WHEREAS, The Town of Munster wants to provide increased flexibility in its personnel management system and to attract and retain competent personnel; and

WHEREAS, The Town Council has determined that the continuance of the deferred compensation plan will serve these objectives; now, therefore, be it

RESOLVED, That the Town Council hereby amends and restates the deferred compensation plan through the ICMA Retirement Corporation 457 Governmental Deferred Compensation Plan and Trust (the "Plan"); and be it further

RESOLVED, That the assets of the Plan shall be held in trust, with the Town of Munster serving as trustee, for the exclusive benefit of Plan participants and their beneficiaries, and the assets shall not be diverted to any other purpose. The Trustee's beneficial ownership of Plan assets held in VantageTrust shall be held for the further exclusive benefit of the Plan participants and their beneficiaries; and be it further

RESOLVED, That the Town of Munster hereby agrees to serve as Trustee under the Plan; and be it further

RESOLVED, That the Town Manager shall serve as the Designated Agent for the Plan and is authorized to sign the Statement of Intent allowing the following.

- 1. The Plan will offer Designated Roth Accounts as described in Article X of the Plan.
- 2. The Plan will allow In-Plan Roth Conversions as provided in Section 10.05.
- 3. Designated Roth Accounts will not be available as a source for loans under the Plan.
