ORDINANCE 1857

AN ORDINANCE AMENDING SCHEDULE "A," A NON-CODIFIED PORTION OF THE MUNICIPAL CODE, AMENDING FEES FOR WATER UTILITIES

WHEREAS, the Town Council has established Schedule "A" for the purposes of centralizing all fees and service charges for Town services, permits, licenses and products; and,

WHEREAS, from time to time various fees and charges are reviewed to ensure they are covering the appropriate share of the cost for providing the service or creating the product.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Munster, Lake County, Indiana, that Schedule "A" of the Munster Municipal Code be amended as follows:

(2) <u>Utilities</u>

- (A) WATER rates and charges will be amended as follows:
- A.1 For the use of and the service rendered by the waterworks system of the Town of Munster Indiana, the following rates and charges, based on the amount of water supplied during each monthly period. All accounts will be billed monthly. All rates will go into effect with the utility bills due June 20, 2022 which reflects usage beginning on or about April 15, 2022.

Deposits shall be equal to two months of current minimum charges for water consumption and hydrant rental based upon the meter size; H.S.D. administrative and user charges, Munster sewer maintenance, and solid waste fees. A deposit for solid waste shall only be required for accounts that are provided solid waste collection by the Town or it's vendor.

A.10 Maintenance of Service Pipes and Meters

A two-day grace period shall be granted to the customer when a leak in their service line has been detected. A charge of 37.35 per day will be made if wasting of water continues.
