Re: Resolution 2093: Road Salt Purchase (2022-2023 Snow Season)

The Town of Munster has participated in the joint purchasing of road salt with the State of Indiana Department of Administration since 2009. For the forthcoming 2022-2023 snow season, Towns had 3 weeks (from March 7 through March 25) to commit to a volume of salt online at the State's web-based tool <a href="https://www.OneIndiana.net">www.OneIndiana.net</a>. Each year's salt demand is estimated based on current usage, salt inventory and future weather trends. A commitment was made on March 23, 2022 for 3,000 tons of treated road salt (same as the prior year's commitment) requiring a minimum purchase of 80% (2,400 tons) or up to 120% (3,600 tons). Any unanticipated salt demand over our max allowed contract purchase would be bought at market price at that time.

Our starting inventory for next year's season should be our full nominal salt dome capacity of 3,300 ton (3,445 ton max rated capacity). This combined with our ability to purchase up to 3,600 tons at preferred State pricing, allows us ample supply for the most severe snow season. Our average salt usage over the past 7 years is 3,231 tons yearly. Our current/historical usage is as follows:
