Re: Fairway mower purchase

Attached is a summary memo from Dan Augdahl, Golf Course Superintendent, after receiving three quotes for a replacement fairway mower for the Centennial Park golf course. Dan gives his explanation and recommendation. Each manufacturer has different horsepower which makes a difference on the hilly terrain of our golf course. There is a preference to stay within one manufacturer for similar equipment to allow for repairs and parts efficiency.

\$75,000 was budgeted for a new fairway mower in the Town's G.O. bond earlier this year per the current equipment replacement schedule. This purchase will trade in a 2008 John Deere 7500 fairway mower with serial #TC7500X010178. This will keep all our fairway mowers from the same manufacturer which will help for maintenance and lower inventory for parts since it uses the same filters, reels, bedknives, etc.

Recommendation:

Staff recommends approving the purchase of a 2023 John Deere 7500A Precision Cut mower from Revels Turf and Tractor at a cost of \$72,594.42 which includes the trade-in of the 2008 John Deere 7500.

Fairway Mower Proposals

This is to replace a 2008 John Deere fairway mower. Trade in is included in final price. In order of preference below. All have Troon pricing which is better than Sourcewell.

1. **John Deere 7500A Precision Cut.** Includes \$2,100 for trade in. \$72,594.42
41.6 HP Handles the hilly property the best and matches the other John Deere 7500A that was purchased in 2021. Available mid-summer 2023.
2. **Jacobsen LF550 4WD.** Includes \$3,000 for trade in. \$74,310.00
Second best option for the hills. 37.5 HP. Replacement parts wait time is a concern.
3. **Toro Reelmaster 5410-D.** Includes \$400 for trade in. \$80,534.26
36.4 HP. Would be second option but much more expensive. Can't deliver until 2024 and there would likely be a price increase at that time.
