# **REQUEST FOR QUOTE – July 28, 2023**

The following describes a crack-seal / sealcoat / striping project at 2 Town facilities that you're invited to submit a QUOTE on. Location is as follows:

- Munster Public Works Public Parking Lots at 508 Fisher Street (located on the entire North side of building, including both parking lots and the connecting street between them), and
- Town Hall Public Parking Lots at 1005 Ridge Rd (located on the entire West side of building, including both
  parking lots and the looped entrance/exit street connecting the two parking lots)....DO NOT INCLUDE East side
  parking lots (for employees)

#### Scope of Work

- WHAT: Crack-seal, sealcoat, stripe all parking lots according to the specifications shown below.
- WHERE: Specific locations of each facility's parking lots to be included are described in the above two bullet points and depicted graphically in two Site Plans (Attached).

## Specifications for Hot Rubber Crack-sealing

- · remove any existing weeds in the cracks.
- blowout all cracks clean using a forced air blower.
- crack-seal all surface cracks (except only the perimeter of any broken/alligatored/shattered areas) with tar prior to sealcoating.
  - o use Hot Rubber sealants specifically designed for sealing cracks in asphalt.
  - o Heat then pump melted rubber into the prepared crack using a hand wand.
  - Slide a steel disk along the crack to leave a uniform band.

## Specifications for Sealcoating

- prior to sealcoating, block off area with barricades & caution tape and complete steps shown above (i.e. weed removal, blowout & crack-seal).
- clean entire pavement area using forced air blowers and sweeping tools.
- sealcoat entire surface with one coat of "industry standard" pavement sealer using squeegees to push the material into the asphalt.
- each completed parking lot must be closed overnight to allow the sealer to cure.
  - NOTE: Munster Public Works will fill any potholes & fix any major surface deficiencies prior to contractor sealcoating.

## Specifications for Striping

- use a <u>reflective acrylic traffic marking paint</u> coating of similar colors throughout to stripe all existing and new parking spaces with appropriate lines, Handicap symbols and stenciling.
- all markings to be measured and chalk lines to be snapped as guidelines for painting.
- provide the maximum number of parking spaces possible, using a minimum 9-foot width, in the same general area where existing spaces are located, including current Handicap accessible spaces.
- add 2 new parking spaces dedicated to the Town Hall Electric Vehicle Charging Station (located adjacent to the 2 vehicle chargers in the extreme SW corner of the Town Hall Southwest parking lot), using appropriate stenciling.
- insure that no wasted space remains in any parking lot. If this requires a few odd-sized larger spaces to work this out, be sure they are appropriately placed near ends or within Handicapped spaces.

#### Warranty

Contractor agrees to warrant against defects in product or workmanship for a period of one (1) year from the date of installation.

• Exclusion: warranty is limited to the repair or replacement of the defect and excludes damage from Acts of God, accidents, excessive traffic loads and snowplowing.

## Scheduling

Contractor to work closely with Public Works to schedule this project in a way that will minimize the inconvenience involved for Town Employees & Visitors. It is expected that both the Public Works two parking lots and Town Hall two parking lots will be tackled one parking lot at a time to allow parking to occur in the adjacent parking lot at all times during the project. This staggered approach must allow one parking lot to dry overnight before the adjacent parking lot is serviced.

#### Deadline for Work Completion

Due to temperature sensitivity of sealcoating below 60 degrees, deadline for work completion is expected by September 29, 2023.

- 7. All invited contractors (whom provide a Quote) will be provided a Summary of Quotes received and the Award decision after the Town Council Meeting.
- 8. After project award before proceeding, please notify Public Works Dept of scheduled start & projected completion timeframe.


