Other factors may be considered as well at the discretion of the Arborist such as whether geographic location of the tree or any other negative influences are contributing or likely to contribute to its demise.

Tree conditions will be documented in a written report with an ISA (International Society of Arboriculture) Basic Tree Risk Assessment Form including photos within one week of inspection.

Any tree recommended for removal will be marked by the Arborist with tags provided by the Town of Munster

Arborist Appraiser to submit documentation report regarding legal discipline concerns when needed.
