Social Center monitoring

It was discovered this spring that the monitoring system at the Social Center was not working. We engaged with Alert Alarm to upgrade the old equipment at a cost of \$1,195. Additionally, the monitoring of this system, which the Fire Chief informed us we are required to have, will cost \$36 per month. Staff has engaged with Alert Alarm from Merrillville, Indiana at a monthly cost of \$36 which is billed quarterly.

Since this is a recurring payment, it requires Board approval.

Recommendation:

A motion to confirm the monthly monitoring cost from Alert Alarm as shown in their May 29, 2024 proposal and direct the staff to sign the monitoring agreement.
