Re: Hubinger Landscaping change orders

The Centennial Park golf buildings landscaping contract was originally approved on 10/17/2023 in the amount of \$148,100.

During construction, staff found it necessary to make changes to the landscaping work completed by the contractor for the benefit of the project including safety, drainage, and long-term maintenance.

The two change orders were as follows:

Change order dated 9/6/24	\$ 13,587.00	(gray stone, outcropping stones, remove topsoil and install stone at retaining wall)
Change order dated 9/30/24	<u>\$ 1,753.00</u>	(sod, river rock, plant relocation)
subtotal	\$ 15,340.00	
Original contract	<u>\$148,100.00</u>	
New Total contract \$	\$163,440.00	

Recommendation:

Staff recommends the confirmation of the change orders dated 9/6/24 and 9/30/24 adding \$15,340 to the original agreement for a new contract total of \$163,440.00.
