-Saw cut and machine demo ~50' x 10' area for new landscaping planter box

Truck asphalt and concrete curb/sidewalk within this scope offsite

Truck excavated earth within this scope offsite for new foundations

Does not include labor and trucking to remove unforeseen debri below grade or mechanical/plumbing infrastructure (I.E unknown foundations, abandoned water/sewer infrastructure etc)

L2 Incorporated will coordinate 811 Call Before You Dig surveying

- -Excavate for new foundation system ~3' below existing grade
- -Install and compact 4" of new 53's stone base under foundation

New footer/foundations dimensions 10' x 50' x 24" (24" reveal above grade, 24" below grade)

- -Form and Pour concrete footer
 - 8" width
 - #5 rebar per code
 - 4,000 psi concrete with high early and chloride (winterization)
- -Form and Pour concrete walls
 - 8" wide
 - #5 parallel rebar at base and top of foundation wall
 - #5 rebar 18" center verticals to tie foundation wall into footer
 - 4,000 psi concrete with high early and chloride (winterization)
