6. *ADMINISTRATIVE MATTERS*

a. *Approval of Park Board Minutes*

August 19, 2025 Minutes

Board Member Repay motioned with a second by Board Member Smith to approve the August 19, 2025 Minutes with the correction that Board Member Paulsen was not in attendance. Board Members Paulsen, Repay, Smith and Pierce voted in favor; none voted against, and the minutes were approved with correction.

b. *Confirmation of Voucher Register(s)*

- i. Approval of Voucher Register 25-9A dated 9/16/25 totaling \$24,230.40
- ii. Confirmation of Voucher Register 25-9B dated 8/1-31/25 totaling \$101,967.69
- iii. Confirmation of Voucher Register 25-9C dated 9/15/25 totaling \$775.00

Board Member Paulsen motioned with a second by Board Member Repay to approve park voucher registers 25-9A, 25-9B, and 25-9C. Board Members Paulsen, Repay Smith and Pierce voted in favor; none voted against, and the voucher registers were approved.

- i. Park Department September Board Report

The Board Report was included in the agenda packet. There were no questions.

7. ITEMS FOR DISCUSSION/ACTION

- a. 2025 Pool Season Report

The pool was open for 11 weeks with 70 employees. There were 8 pool sponsors. Over 21,000 guests visited the pool during the season; 65% of season pass holders were residents and 35% were non-residents. There were 64 saves/rescues, 5 accident reports were filed and no unusual incidents occurred. Management staff worked well with regular staff. With revenues from sponsorships, rentals and programs, season passes and daily admissions, less expenses for personnel, supplies, chemicals and utilities, there was a net profit of \$378.14.

- b. Resolution 2025-04 Declaratory Resolution for Issuance of Bonds

Board Member Repay motioned with a second by Board Member Paulsen to adopt Resolution 2025-04. Board Members Paulsen, Repay, Smith and Pierce voted in favor; none voted against and Resolution 2025-04 was adopted.

8. ADJOURNMENT

President Pierce called for a motion to adjourn.

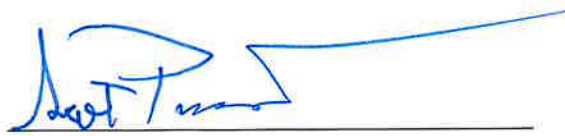
