AUTOMATIC PAYMENT: A FAST, EFFICIENT WAY TO PAY YOUR WATER UTILITY BILL

Electronic banking (whether online or Automated Clearing House) is a modern, cost-efficient method of paying routine bills. The Town of Munster wants to help make it easy for you to take advantage of the available technology and ensure that your water utility account is properly credited on time.

Why not consider paying your water bill using Automated Clearing House (ACH)? After the initial one-month setup, your payment will be automatically withdrawn from your bank account each month on the due date. You will continue to receive a statement detailing the monthly charges, but you will no longer have to initiate individual monthly payments. LEAF AND BRANCH COLLECTION

Do not put leaves in your garbage can or in bags; Able Disposal will \underline{not} pick them up. Rake your leaves to the curb for Munster's Fall Leaf Collection.

The Town of Munster's branch pick up will end on Friday, November 13, and the fall leaf pick-up will end on Friday, December 4. There will no longer be pick up of leaves and branches until spring. The Public Works Department must now prepare for snow and ice removal.

SOUTH STREET TO GET NEW WATER MAIN

Work will soon begin on the replacement of the water main on South Street from Harrison west to the old railroad right of way. Grimmer Construction was awarded the \$82,000 contract which will replace an old 4 inch water main which has a history of leaks, with a new 6 inch water main. This project will increase water pressure, improve water quality, and offer better fire protection by both replacing and adding fire hydrants. The new main will be tied in at the west end to the water main on Manor Avenue to improve water circulation throughout the neighborhood. Construction is expected to begin the first week in November. WORK ON CALUMET AVENUE, FISHER TO 45TH, DELAYED

Based on the lateness of the season and the cold and rainy fall, the Town has decided not to permit the contractor to begin work on the Calumet Avenue pavement from Fisher Street to 45th. The project was awarded earlier this summer to Rieth Riley, but required paperwork at the Indiana Department of Transportation delayed start-up. The project involves adding a lane and then resurfacing the entire street. The added lane will provide a continuous left turn lane the entire distance. This will improve traffic flow so that left turns onto the busy driveways in the commercial area will not slow down through traffic. The contractor will be able to work behind the curbing installing storm sewers, relocating underground utilities, etc, so that next spring the widening will go quickly. If the contractor would have been permitted to begin pavement work this fall then it was likely that the street would be reduced to one lane in either direction with barricades and uneven pavement through the winter. NORTHCOTE BRIDGE STUDY

The Northcote Bridge has been the subject of much discussion both before, but especially since the September, 2008 flood. Although it was not the source of the flooding, the elevation of the bridge is below the elevation of the flood walls and levees which are currently being installed. The Army Corps of Engineers anticipates sandbags being used to close the bridge when floodwaters rise to a certain elevation. The Munster Town Council would prefer another alternative which would offer continuous flood protection without requiring anyone to do anything. The Lake County Highway Department has jurisdiction over bridges in the county. They, along with Hammond and Munster, met and discussed the need to study alternatives which would prevent the bridge from being a source of flooding in the future. The three agreed to share the cost of the study and an engineering company was hired. DLZ identified several alternatives including replacing the bridge with one at a higher elevation, closing the bridge and continuing the floodwall across the current street, placing flood walls on either side of the current bridge, installing flood gates which could be closed when the flood water reached a certain elevation, and continuing to rely on sandbags. They identified the strengths, weaknesses and costs for each. Lake County, Hammond, and Munster will continue to meet and discuss the results of the study. HOLIDAY SAFETY TIPS FROM THE MUNSTER POLICE DEPARTMENT

The Munster Police Department would like to remind residents of the following tips in regards to safety during the holidays:

- Do not carry large amounts of cash when shopping.
- Be wary of people in stores attempting to distract you while an accomplice steals your wallet or purse.

- Carry your wallet in your front pocket when shopping.
- Shop with a friend.
- Don't leave large amounts of purchased items in plain view inside your vehicle. Only visit a few stores at a time and store items inside your trunk when necessary.
- Try to park in a well-lit area and have your keys ready when coming from or going to department stores. Panic alarms can be helpful in attracting attention if necessary.
- Report suspicious people who appear to be sitting randomly in cars or who are aimlessly walking through parking lots looking inside vehicles.
- If you are attacked, try to remain calm. Hand over items such as wallets or purses and do not try to be a hero. Items can be replaced, your life cannot.
- If you are leaving Town for the holidays, contact the Police and notify your trusted neighbors. Used timed lighting and ask a friend to park in your driveway.

SNOW REMOVAL ORDINANCE

With winter nearly here, snow is not far behind. Please keep in mind according to Town of Munster ordinance, it is unlawful for any person (resident or contractor) to throw, push, or deposit snow, slush, or ice onto any street or sidewalk. Those who violate this ordinance will be subject to a fine.

Also, Town Ordinance 46-3 pertains to the removal of snow and ice from sidewalks. The Ordinance states that the owner and/or the occupant of any dwelling, building or subdivided lot or property shall keep the sidewalks in front of thereof clean at all times of the year. Within 24 hours after any snow fall or formation of ice, such snow or ice shall be removed from the sidewalks.
