

INFORMATION FOR SOLICITOR'S LICENSE

The application fee is **\$25.00** *per person* and is a **NON-REFUNDABLE** fee for background investigation. A government-issued form of ID (such as a driver's license) is also required at the time of application. The investigation process may take anywhere from two to ten days for approval. Upon approval by the Munster Police Chief, your application will be sent back to the Clerk-Treasurer's office at which time you will be notified. You may then come in and obtain your license of choice:

SOLICITOR'S STATEMENT OF UNDERSTANDING

I understand that Munster residents do not appreciate anyone coming to their door that they do not know and have not invited.

I fully understand that this permit does not entitle me to become disrespectful, discourteous, intimidating or abusive to any Munster resident for any reason.

I understand the meaning of the words "no" and "I'm not interested". I further understand that if any Munster resident reports that they had to use words or any combination of those words more than once during my visit, that my permit to solicit in Munster is likely to be revoked without refund and that any future permits to solicit here is doubtful.

I understand that I am expected to honor any non-solicitation signs.

I understand that the reason for the dusk curfew for soliciting in Munster is for the following reasons:

1. To protect the quality family time Munster residents expect & deserve.
2. To protect Munster solicitors from injury caused by poor visibility.

I further acknowledge that any violation of the Munster solicitation ordinance will likely result in the revocation, without refund, of my permit to solicit and that any future permits to solicit here would be doubtful.
