## What is Domestic Violence?

Domestic violence can be defined as a pattern of behavior in any relationship that is used to gain or maintain power and control over an intimate partner.

Abuse is physical, sexual, emotional, economic or psychological actions or threats of actions that influence another person. This includes any behaviors that frighten, intimidate, terrorize, manipulate, hurt, humiliate, blame, injure or wound someone.



Domestic violence can happen to anyone of any race, age, sexual orientation, religion or gender. It can happen to couples who are married, living together or who are dating. Domestic violence affects people of all socioeconomic backgrounds and education levels.

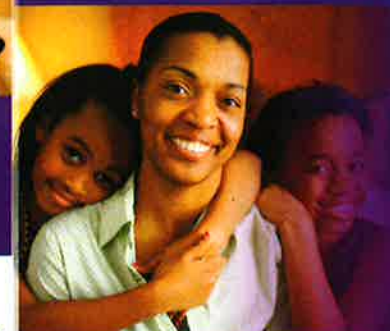

St. Jude House is a family violence prevention center and shelter that has provided comprehensive services to survivors of domestic violence and sexual assault since 1995. In the spirit of St. Francis of Assisi and Mother Theresa Dudzik, we offer hope and promise survivors and their families.

## Our Vision

## Our Services

St. Jude House provides services to clients without regard to race, color, religion, gender, national origin, age, disability, or other status applicable by law. Our physical facility is accessible to differently-abled clients. Our shelter services are available 24 hours a day, 365 days a year. In addition to offering shelter services, we provide the following:



- Residential or non-residential one-on-one advocacy, support, and groups for adult survivors of domestic violence, sexual assault or incest; a 24-hour rape response team; dating violence and sexual assault support advocacy
- Residential or non-residential one-on-one advocacy, support, and groups for children living in violent homes and child survivors of incest
- Legal advocacy for assistance in filing battery complaints, protective orders, support during court hearings and attorney referrals
- Case management programs including short- and long-term goal planning for survivors and families to achieve self-sufficiency

## Our Commitment

Our commitment begins with the clients we serve. We support our clients every hour of every day to ensure they succeed in breaking the chains of domestic violence. In addition to our clients, our commitment extends beyond our doors to providing education on domestic violence to community organizations.

## Our Outreach

St. Jude House provides educational programs to community groups, service providers, schools, churches, hospitals, law enforcement, medical professionals and the legal community covering topics on domestic violence, sexual assault, dating violence, good touch/bad touch, nonviolent discipline techniques, conflict resolution and workplace violence. 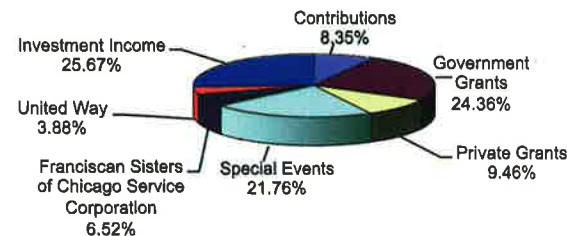
Our strategic plan reaffirms our commitment to breaking the generational cycle of abuse through:
