LANDSCAPE/MULCH BED MAINTENANCE AREA: Includes the single landscape/mulch bed located directly in front of the house, along the sidewalk between the driveway and the house and the planting areas that run along the East and SE side of the house only.

MAINTENANCE DATES: April 1 through September 30: 1x per month at the contractor's discretion. Director of Parks and Recreation must receive notice of work dates.

LANDSCAPE AREA & MULCH BED WEED CONTROL: Area shall be weeded by hand. A pre-emergent shall not be used.

INSECT AND DISEASE: Monitor damaging insects and disease. Notify Parks and Recreation Department staff of any problems and submit proposals for treatments.

PRUNING: Periodic pruning of dead or dying plant material located in the mulch beds in front of the house, in the native plantings to the south and SE of the house, along the sidewalk between the driveway and the house and along the length of the driveway (first 48" only). Do not prune beyond 48" of the driveway.

TRIMMING/WEEDING: Low hanging branches and plants encroaching within 24" of the driveway shall be trimmed back only. Periodic weeding shall take place within this same area as well.
