LIGHTNING PREDICTION AND WARNING SYSTEM

The Thorguard Lightning Prediction Warning System will be reactivated in April at the following parks in town: Community Park, Beech Park, Grove Park, Frank H. Hammond Park, Stewart Park, White Oak Park, Twin Creek Park, Bluebird Park and Centennial Park.

NOTE: The system will be operational 7 days a week from 6 am to 11 pm starting in April through November 31. The warning system may be tested, on the first Wednesday of each month at 10 am. The Thorguard Lightning Prediction System will sound a warning horn (15 second blast) when a potentially dangerous weather situation is approaching. If you hear the alarm, clear the park immediately and seek proper shelter. All activities must cease once you hear the horn. Wait for the all clear (3 short horn blasts), before returning to normal activities. If the all clear does not sound after 30 minutes, cancel your park event. This system is here for your safety.



Executive Order #20-04

Per Indiana Governor Eric Holcomb's Executive Order #20-04, the Munster Police Department is closed to the public until further notice. Record requests, such as: police reports, accident reports, gun permits, vehicle releases, etc., can and should be done via telephone or email. Please call 219-836-6630 or 219-836-6650, between 8:00 a.m. and 4:00 p.m., Monday thru Friday. Backgrounds, fingerprinting services, and vin checks are suspended until further.

In addition to this, the Munster Police Department will be screening calls for service to determine the appropriate level of response. Calls for service that are deemed to be nonemergency in nature may be taken over the phone.

When calling to report your call for service, regardless of the nature, provide as much information to the call taker as possible to include a current phone number. If your request is determined to be of a non-emergency nature by one of our supervisors, an officer will call you back at the phone number provided, as soon as possible. The Munster Police Department response to emergency calls will remain unchanged throughout the COVID-19 outbreak.

During this evolving national health emergency the Public Works Department like other Town Departments are following extraordinary protocols to help protect the health of its employees and the residents that we serve. Our plan is to minimize in-home services such as water meter installations but to continue essential services and emergency response. We've beefed up our internal sanitation and hygiene protocols to keep Town facilities as clean as possible and are practicing social distancing, all in the effort to halt the spread of any virus. We've identified essential services and will continue to dedicate resources and respond to those primary needs, namely; maintaining a safe and robust water supply, fixing water main breaks, checking sanitary sewer backups to eliminate blockages in Town lines, removing storm damaged trees and fixing pot holes.

Crews are going through the entire Town scouting out every location that has been damaged by our snowplows. If your lawn or parkway was damaged by our plows, please call 219-836-6970 to make sure we have your address. Throughout April we will be reseeding all these areas. We will also be

restoring watermain break sites that developed over the winter during this time. We should be complete by the end of April.



April showers bring more than May flowers. Spring rains can cause flooding of yards and streets. Most of the time flooding can be prevented by making sure the drain grates are kept free of debris. It doesn't take much to clog a drain and have it cause significant flooding of streets and/or yards. As

material such as leaves, twigs, and litter are washed from the ground surface it collects onto the drain grating and acts like a rubber plug. The flow of water runoff into the drainage system is drastically reduced when material collects near or on the drain grate. Residents can do their part by helping keep drains near your home free of debris.



SPRING LEAF/BRANCH COLLECTION

Both starting April 1, 2020

Weather permitting for 2 weeks. Munster will be having the spring leaf collection. Do not put leaves in your garbage can, plastic bags or in brown bags, Waste Management will not pick them up. Rake your leaves to the curb for the spring leaf collection.

Since pick-up quantities are not known, it is difficult to predict exactly which neighborhood will be picked up on which day, so please have your leaves out. We will start on the northwest section of Town and work south. Please place your leaves in a continuous long pile.

We will be using a leaf vacuum to collect your leaves. If your street has curbs, please place your leaves right behind the curb on the grass parkway. **PLEASE DO NOT PLACE LEAVES IN THE STREET.** If your street does not have curbs, please place your leaves on the edge of the street pavement. Also, please be careful not to mix leaves with large sticks, rocks or other debris, which could cause injury to an employee or damage to the equipment. Thank you for your cooperation. Weather permitting; branches will be picked up with the chipper. These branches should be no longer than 5' long and 5" in diameter.

Twigs and yard waste should be put into your garbage cans or bagged. Small branches should be bundled and tied; these will be picked up with your garbage. If you have any questions, you can contact the Public Works Department at 219-836-6971.
