Attached is the RFI submitted by Walsh (not included with the response). The below reference to INDOT Standard Specification 109.04 is a Cost Reduction Incentive (CRI). However, only proposals resulting in the Department's portion (50%) of the estimated net savings equal to or greater than \$10,000 are considered. It also noted below that the right of way may be impacted, which I believe the perpetual easement including subterranean tie backs included in the cut wall design may also apply. In talking to Walsh, they claim to have incorporated the cost for T-Wall into their bid. Therefore, there would be no savings or CRI submitted for this change.

Our opinion is that the Town should be receptive to the proposed contract change which is conceptually described in this RFI. We would suggest encouraging the contractor to move forward with a formal change proposal for full evaluation of this concept and submit for review by the Town.
