REMOVING SNOW AND ICE FROM SIDEWALKS

It is especially important for residents to remember the Town of Munster's ordinance in regards to removing snow and ice from sidewalks. If you leave snow along your sidewalks it could prevent students and other pedestrians from being able to get through and could lead to them having to walk in the street. For everyone's safety, please follow this ordinance:

- The owner and/or occupant of any dwelling, building or subdivided lot or property shall keep the sidewalks in front thereof clean at all times of the year. Within 24 hours after any fall of snow or formation of ice, such snow or ice shall be removed from the sidewalks.
- It shall be unlawful for any person to throw, push or deposit in any manner snow, slush or ice onto any street or sidewalk in such a manner as to impede the safe progress and movement of vehicular or pedestrian traffic.
- Persons who violate this subsection are responsible for the costs incurred by the town to remove the impediment to safe progress and movement of vehicular and pedestrian traffic.

MAILBOXES AND SNOWPLOWING

Residents are reminded to kindly inspect their mailbox prior to the winter to ensure that it is in sound structural shape. Rarely does a snowplow hit a mailbox, but often snow thrown from a plow truck hits mailboxes, which can sometimes cause damage to a mailbox especially if it is loose or has a rotted post. It has been our practice to replace damaged mailboxes if caused by a Town snowplow but only if the mailbox was in prior good condition. It is the resident's responsibility to ensure that their mailbox is solid enough to withstand being hit by the often-wet heavy snow thrown from a plow truck. If a damaged mailbox is determined to be from a weakened or deteriorated condition, the Town is relieved of any responsibility to repair it if snow operations cause further damage.

PLOWING

The Town Public Works Department starts plowing when there is an inch of snow on the road, beginning with main streets, hospital areas, school areas, secondary streets and hilly streets. These high priority areas get plowed first (ahead of residential streets, cul-de-sacs and alleys) and are salted down to bare pavement until the snow has stopped. Alleys are plowed last and only after a minimum 4" snowfall.

- 26% of households do not have smoke detectors.
- 29% of households have smoke detectors that do not work or are outdated.
- 3 out of 5 home fire deaths result from fires in properties with no smoke alarms or no working smoke alarms.
- Half of home fire deaths happen between 11:00 p.m. - 7:00 a.m. when most people are asleep.
- The risk of dying in a home fire is cut in half in homes with a working smoke alarm.
- Annually there are over 2500 deaths from house fires.



Fire Safety

Thanks to a grant given to the department from the Rotary Club of Munster, the Munster Fire Department will be starting a new home safety initiative in the upcoming weeks - "Don't Let Your World Go Up In Smoke."

The purpose of this program is to ensure that every home has smoke detectors installed and in working order. The alarms will be provided and installed by a member of the Fire Department. In conjunction with the smoke alarm installation, the Munster Fire Department and Rotary Club of Munster will also offer a Home Fire Safety Inspection. There is no charge for either of these services.

To participate in the program for a smoke detector installation and/or the home safety inspection you will be required to submit an application to the Fire Department. Applicants will then be contacted to set up an appointment for the installation and/or inspection.

South Shore Railroad West Lake Construction to Begin in January

Beginning in January 2022, contractors for the Northern Indiana Commuter Transportation District (NICTD) and NIPSCO will begin construction work for the West Lake commuter rail project. Initial work will include the relocation of aboveground utility poles and lines, relocation of underground utilities, site clearing including tree cutting, and installation of erosion control measures such as silt fencing. Residents should expect some road closures during the construction.

HOLIDAY SEASON SAFETY TIPS FROM THE MUNSTER P.D.

- When shopping, attempt to do so with a friend.
- Always carry your wallet in your front pocket or keep your purse zipped up and slung in front of you while shopping or at holiday events to help prevent pickpocket attempts. Never leave your purse in your shopping cart and be alert for distraction techniques used by pickpockets.
- If you are shopping at multiple places, store purchased items in your trunk and out of public view. Never leave shopping bags in plain view inside of your vehicle. Ask store security or the police department for an escort to your car if you are concerned about walking out to it.
- Never carry large amounts of cash or unnecessary credit cards. Only take what you need to shop with.
- Keep your home well-lit at night by using dusk-to-dawn, motion-detecting, and timed lighting and keep shrubs trimmed below the window line to help prevent hiding places.
- Do not display large amounts of gifts under your Christmas tree in plain view through your home's window.
- Use caution with anyone who comes to your door or calls you asking for donations to various causes. Only provide donations directly to causes or charities that you know and trust, and never provide personal or bank account information over the phone.
- Only allow reputable companies (that are permitted through the town) or the children of friends to assist you with snow removal. Never allow strangers into your home.
- If you are leaving for the holidays, contact the Records Division of our police department by calling (219)836-6650 and also encourage trusted neighbors to keep an eye on your home. Stop mail, arrange for snow removal, and ask a neighbor to park in your driveway to make it look as if someone is at home.
