ORDINANCE 1869

AN ORDINANCE AMENDING THE STOPPING, STANDING AND PARKING OF VEHICLE REGULATIONS WITHIN THE TOWN OF MUNSTER TO PROVIDE FOR METERED PARKING

WHEREAS, the Town Council of the Town of Munster is the municipal legislative body of the unit; and

WHEREAS, The Town of Munster, its Staff, and consultants have reviewed and recommended various changes to the Munster, Indiana Code regarding the Stopping, Standing and Parking of vehicles; and

WHEREAS, based on those recommendations, the Munster Town Council has concluded that amendments to Chapter 54 – Traffic and Vehicles, Article IV – Stopping, Standing and Parking, to include provisions for metered parking, in accordance with I.C. 36-9-12 et seq., is appropriate; and

WHEREAS, The Munster Town Council deems it to be in the best interest of the general health, safety, and welfare of the citizens of the Town of Munster to amend Chapter 54 – Traffic and Vehicles, Article IV – Stopping, Standing and Parking of the Munster Code of Ordinances to include provisions for metered parking.

Now, therefore, be it **ORDAINED** by the Town Council of the Town of Munster, Lake County, Indiana as follows:

1. <u>Chapter 54 – Traffic and Vehicles, Article IV – Stopping, Standing and Parking, of the</u> <u>Munster Municipal Code, be amended by adding a new division, *Division 3. – Metered* <u>Parking., to read as follows:</u></u>

Division 3 - Metered parking

Section 1. – Definitions.

The following words, terms, and phrases, when used in this division, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Parking meter means any mechanical device or digital parking enforcement technology used for the regulation of parking. The term *parking meter* includes, but is not limited to, a mechanical device placed or erected on any parking area of the Town where parking fees are required to be paid to park and that accepts payments onsite; a parking management service accessed through a smartphone app, website browser, or pay-by-phone to make payment of parking fees when required to pay to park in specified areas of the Town; and license plate recognition (LPR) technology that identifies license plates of vehicles entering and exiting parking areas of the Town where parking fees are required to be paid to park to determine if the vehicle has an existing annual parking pass or if the driver made payment via the on-site mechanical device, smartphone app, website, or by phone.

Section 2. – Metered parking spaces.

All parking spaces in Centennial Park in the Town of Munster are metered parking spaces. This includes all parking spaces in the north parking lot of Centennial Park (entry from Calumet Avenue at Superior Avenue), and the south parking lot of Centennial Park (entry from Calumet Avenue at Columbia Avenue).

Section 3. - Parking meter fund.

- (a) A parking meter fund (fund) was established within the office of the clerk-treasurer. This special non-reverting revenue fund is authorized under Indiana Code 36-9-12 et seq.
- (b) All monies received by the Town of Munster from parking fees paid via a parking meter, in accordance with this division, shall be deposited into this fund.

Section 4. - Applicable parking fees.

- (a) The fee to park in a metered parking lot is \$2.00 per hour or \$5.00 per day. A fifteen (15) minute grace period is allotted upon a vehicle's entry into a metered parking lot whereby parking fees will not be assessed if the vehicle exits the lot within the grace period. Parking fees will be assessed if the vehicle remains in the lot beyond the fifteen (15) minute grace period regardless of whether the vehicle is parked in a parking space or not.
- (b) An annual pass to park in a metered lot may be purchased online each calendar year with the Town of Munster. The fees for an annual pass to park in metered lot shall be as follows, subject to all conditions of this division and the applicable parking management agreement:
 - (1) Town of Munster residents may register the license plates of two (2) vehicles per household for an annual parking pass at no cost (\$0.00), per calendar year. Residents may register the license plates of additional vehicles per household (vehicle 3, 4, etc.) for an annual parking pass for \$20.00 per vehicle, per calendar year.
 - (2) Non-residents of the Town of Munster may register the license plate of a vehicle for an annual parking pass for \$120.00 per vehicle, per calendar year.
- (c) The Town of Munster will validate parking for Centennial Park Dog Park annual pass holders, Centennial Park Golf Course members, daily golfers, and during the rental of facilities at Centennial Park.
- (d) The Town Council may suspend enforcement of parking meters in the event of inclement weather, or under other circumstances that the Town Council deems appropriate and reasonable.
- (e) The Superintendent of Parks and Recreation is authorized to alter or modify the hourly charge or method of payment for parking in all metered parking lots in conjunction with special events and promotional activities.
- (f) The Superintendent of Parks and Recreation is authorized to charge a daily rate of no more than \$5.00 per day to park in a metered parking lot on days that the parking meter equipment is non-functional.

Section 5. – Parking law conflicts.

The provisions of this division shall not be construed to modify or change the traffic and parking laws set forth in other portions of this Code which restrict or prohibit parking.

This Ordinance shall be effective from and after adoption by this Council and compliance with I.C. §36-5-2-10.

Now, therefore, be it **ORDAINED** that the above-referenced Ordinance is hereby enacted.
