# TOWN OF MUNSTER MINUTES OF A SPECIAL MEETING OF THE TOWN COUNCIL JULY 6, 2022

A special meeting of the Munster Town Council convened at 7:00 p.m. on Wednesday, July 6, 2022. Ordinance 1830 is the basis for holding electronic meetings. The announced meeting location was Munster Town Hall. Councilors, Staff, and the public had the option to participate via Zoom meeting technology.

Councilors Chuck Gardiner, Andy Koultourides, Lee Ann Mellon, and Ken Schoon were physically present at Town Hall. Councilor Steven Tulowitzki was present in the virtual setting. President Gardiner presided. Also present in Town Hall were Clerk-Treasurer Wendy Mis, Controller Patricia Abbott, Town Manager Dustin Anderson, Deputy Town Manager Jill DiTommaso, Town Attorney Dave Westland, Police Chief Stephen Scheckel, Police Lieutenant Daymon Johnston, Planning Director Thomas Vander Woude, and Munster representative to the Hammond Sanitary District Mike Hawkins. The news media were not represented.

President Gardiner opened the meeting with a moment of silence followed by the pledge of allegiance.

#### PROCLAMATION: NATIONAL NIGHT OUT AGAINST CRIME

President Gardiner read the proclamation recognizing August 2, 2022, as National Night Out Against Crime in the Town of Munster.

Councilor Koultourides moved, with a second by Councilor Schoon, to adopt the "National Night Out Against Crime Proclamation." Councilors Schoon, Mellon, Koultourides and Gardiner voted in favor; none voted against. Motion carried and the proclamation was adopted. Technical issues prevented Councilor Tulowitzki from voting.

# **PUBLIC COMMENT**

The Town of Munster accepted public comment submitted both in-person and electronically. Councilor Schoon moved, with a second by Councilor Koultourides to suspend the rules, waive the readings, and adopt the Consent Agenda as presented. Councilors Schoon, Mellon, Tulowitzki, Koultourides, and Gardiner voted in favor; none vote against.

## **OLD BUSINESS**

## **ORDINANCE 1865: PARKING METER FUND**

Introduced ORDINANCE 1865 is AN ORDINANCE CREATING THE PARKING METER FUND (2207). The ordinance had first read at the May 16, 2022, meeting. There was a delay in presenting the ordinance for second reading as further legal review was needed. Clarifying language has been added.

The ordinance will formally create the Parking Meter Fund (2207) to account for the fines and fees collected through the managed parking program at Centennial Park.

Councilor Mellon moved, with a second by Councilor Koultourides, to adopt Ordinance 1865 as presented. Councilors Schoon, Mellon, Tulowitzki, Koultourides, and Gardiner voted in favor; none voted against.

# ORDINANCE 1870: AMENDMENT #2 TO 2022 SALARY ORDINANCE

Introduced ORDINANCE 1870 is AMENDMENT #2 TO THE 2022 SALARY ORDINANCE. First reading was held on this ordinance at the June 20, 2022, meeting. If adopted, the ordinance will amend the Salary Ordinance by reducing the number of Police Lieutenants by one and creating a new civilian position within the Police Department.

Councilor Koultourides moved, with a second by Councilor Mellon, to adopt introduced Ordinance 1870 on second reading tonight. Councilors Schoon, Mellon, Tulowitzki, Koultourides, and Gardiner voted in favor; none voted against. Motion carried.

# **NEW BUSINESS**

# **RESOLUTION 2097: RELEASE OF LETTER OF CREDIT**

Proposed RESOLUTION 2097 is A RESOLUTION RELEASING THE PROPERTY OWNER'S LETTER OF CREDIT FOR LANDSCAPING RESTORATION AT 822 RIDGE ROAD. The property at 822 Ridge Road was cited for ordinance violations for failing to maintain the landscaping. In order to ensure completion of the work by the spring of 2022, the property owner provided a letter of credit to the Town. The letter of credit was in the amount of \$12,503.95 which matches the contractor's estimate to complete the work.

The landscaping was completed and inspected in June 2022 and found to be acceptable. Staff now recommends releasing the letter of credit. Resolution 2097 has been drafted for this purpose.

Councilor Koultourides moved, with a second by Councilor Schoon, to adopt Resolution 2097 releasing Letter of Credit #1060006162 posted January 25, 2022, in the amount of \$12,503.95 to Robert C. Miller. Councilors Schoon, Mellon, Tulowitzki, Koultourides, and Gardiner voted in favor; none voted against.

# **RESOLUTION 2098: RELEASE OF LETTER OF CREDIT**

Proposed RESOLUTION 2098 is A RESOLUTION RELEASING THE PROPERTY OWNER'S LETTER OF CREDIT FOR LANDSCAPING RESTORATION AT 9140 CALUMET AVENUE. The property at 9140 Calumet Avenue was cited for ordinance violations for long grass and weeds as well as failing to maintain landscaping. In order to ensure completion of the work by the spring of 2022, the property owner provided a letter of credit to the Town. The letter of credit was in the amount of \$48,440.48 which matches the contractor's estimate to complete the work.

The landscaping was completed and inspected in June 2022 and found to be acceptable. Staff now recommends releasing the letter of credit. Resolution 2098 has been drafted for this purpose.

Councilor Koultourides moved, with a second by Councilor Mellon, to adopt Resolution 2098 releasing Letter of Credit #21-00026 in the amount of \$48,440.48 to Dreamspace Munster LLC. Councilors Schoon, Mellon, Tulowitzki, Koultourides, and Gardiner voted in favor; none voted against.

# ACCEPTANCE OF PROPOSAL: PEDESTRIAN CROSSING FRAN LIN PARKWAY AND CALUMET <u>AVENUE</u>

Three legs at the intersection of Fran Lin Parkway and Calumet Avenue are equipped with pedestrian crossing signals. There is an existing curb ramp and striped crosswalk provide a crossing route at the southern leg of Calumet Avenue, but there is no pedestrian signal.

In an ongoing effort to improve pedestrian safety and accessibility and at the request of local business owners in the area, the Town solicited a quote from Midwestern Electric to install pedestrian crossing equipment in this location. The quote is for \$7,185.00 and includes installation of the pedestal pole and foundation at the southwest corner of the intersection complete with signals and push buttons for the crosswalk. The project will be funded by the Wheel Tax Fund.

Councilor Mellon moved, with a second by Councilor Schoon, to approve the quote from Midwestern Electric in the amount of \$7,185.00 to install a crosswalk at the southern leg of Fran Lin Parkway and Calumet Avenue. Councilors Schoon, Mellon, Gardiner, Tulowitzki, and Koultourides voted in favor; none voted against.

# **APPROVAL OF INDOT CONTRACT: CCMG 2022-01**

The Town has applied for a Community Crossings Matching Grant in the first round of applications for 2022. INDOT has issued contract #063690 to complete the mill and overlay of four streets as follows.

The grant is valued at \$374,652.49 with the Town paying an equal amount towards the road work. Included in the work is the watermain replacement on Hawthorne Drive at a cost of \$156,195.00. The watermain work will be funded completely by the Town from either the Water Funds or the ARP Fund. This makes the total project cost \$905,499.97. The street work will be funded by the 2021 General Obligation Bond Proceeds.

Councilor Koultourides moved, with a second by Councilor Schoon, to authorize the Town Manager to execute Contract #063690 with the Indiana Department of Transportation in the amount of \$374,652.49 to resurface .686 miles of local roads and streets. Councilors Schoon, Mellon, Tulowitzki, Koultourides, and Gardiner voted in favor; none voted against.

# CDM SMITH CONTRACT AMENDMENT #2: MAIN STREET STATION ARCHITECTURAL SERVICES

Council approved a contract with CDM Smith at the May 17, 2021, meeting. At the April 4, 2022, meeting, Council approved an amendment to the agreement to increase the not-to-exceed amount from the original \$50,000.00 to \$92,675.00 and to extend the contract to June 30, 2022.

Staff has presented Amendment #2 which will extend the contract to the end of the year. The additional time allows the contractor to verify the design changes are being incorporated. There is no cost change.

Councilor Schoon moved, with a second by Councilor Koultourides, to authorize the Town Manager execute Amendment 2 of the agreement between CDM Smith and the Town of Munster. Councilors Schoon, Mellon, Tulowitzki, Koultourides, and Gardiner voted in favor; none voted against. Motion carried.

# ORDINANCE 1871: AMENDING THE VEHICLE TOWING AND IMPOUNDMENT REGULATIONS WITHIN THE TOWN OF MUNSTER

Proposed ORDINANCE 1871 is AN ORDINANCE AMENDING THE VEHICLE TOWING AND IMPOUNDMENT REGULATIONS WITHIN THE TOWN OF MUNSTER. This ordinance amends the existing towing and impound ordinance to address issues specific to Centennial Park. The ordinance allows for an authorized agent to enforce parking and order towing at Centennial Park. The ordinance also sets the towing, storage, and release charges.

Councilor Mellon moved, with a second by Councilor Schoon, to hear Ordinance 1871 AN ORDINANCE AMENDING THE VEHICLE TOWING AND IMPOUNDMENT REGULATIONS WITHIN THE TOWN OF MUNSTER on first reading tonight and set second reading for July 18, 2022. Councilors Schoon, Mellon, Koultourides, and Gardiner voted in favor; Councilor Tulowitzki voted against. Motion carried.

# ORDINANCE 1872: AMENDING THE METERED PARKING REGULATIONS WITHIN THE TOWN OF MUNSTER

Proposed ORDINANCE 1872 is AN ORDINANCE AMENDING THE METERED PARKING REGULATIONS WITHIN THE TOWN OF MUNSTER. Ordinance 1872 further defines metered parking at Centennial. The ordinance includes fines for violations.

Councilor Koultourides moved, with a second by Councilor Schoon, to hear Ordinance 1872 on first reading tonight and set second reading for July 18, 2022. Councilors Schoon, Mellon, Koultourides, and Gardiner voted in favor; Councilor Tulowitzki voted against.

## **LEGAL SETTLEMENT**

A settlement agreement was presented to Council for their approval.

Councilor Mellon moved, with a second by Councilor Koultourides, approve a settlement with K & S Engineering for \$3,750,000.00 and authorize Town Council President to sign a consideration for a partial settlement for Centennial Park Lawsuit. Councilors Schoon, Mellon, Tulowitzki, Koultourides, and Gardiner voted in favor; none voted against.
