# TOWN OF MUNSTER MINUTES OF A SPECIAL MEETING OF THE REDEVELOPMENT COMMISSION JULY 6, 2022

A special meeting of the Munster Redevelopment Commission convened at 7:28 p.m. on Wednesday, July 6, 2022. Ordinance 1830 is the basis for holding electronic meetings.
