ORDINANCE NO:1886

AN ORDINANCE AMENDING THE TOWN ORDINANCE NO. 1578, BEING "AN ORDINANCE AMENDING THE TOWN CODE OF THE TOWN OF MUNSTER TO ADOPT DISTRICTS FOR THE AT LARGE ELECTION OF EACH RESPECTIVE MEMBER OF THE TOWN COUNCIL" PERTAINING TO THE GEOGRAPHIC BOUNDERIES OF DISTRICTS (WARDS) IN THE TOWN OF MUNSTER, LAKE COUNTY, INDIANA, AND REPEALING ALL TOWN CODE SECTIONS AND ORDINANCES, OR PARTS THEREOF, IN CONFLICT HEREWITH.

WHEREAS, the Town Council of the Town of Munster, Lake County, Indiana, (hereinafter the "Town Council"), review the applicable provisions of the Indiana Code, specifically, I.C. § 36-5-2-4.1, 36-5-2-5, and 3-11-1.5-32, each as amended from time to time pertaining to ward boundary districts within the Town for the purpose of conducting elections of Town Officers; and

WHEREAS, the Town Council, has been informed and advised that it has been mandated by applicable statute to re-establish the boundaries of districts (wards) within the Town on the basis of the Y2020 Census for purposes of conducting elections of Town Officials; and

WHEREAS, on December 28, 2012, the Town Council did adopt Ordinance No. 1578, the same being "AN ORDINANCE AMENDING THE TOWN CODE OF THE TOWN OF MUNSTER TO ADOPT DISTRICTS FOR THE AT LARGE ELECTION OF EACH RESPECTIVE MEMBER OF THE TOWN COUNCIL"; and

WHEREAS, the Town Council has reviewed the provisions of adopted Town Council Ordinance No. 1578 pertaining to the current District (Ward) Boundaries; and

WHEREAS, the Town Council has reviewed the current census data from the Y2020 Census relating to the population increase throughout the Town of Munster; and

WHEREAS, the Town Council has determined that the present Ward Boundary District delineations set forth in adopted Town Ordinance No. 1578, require amendment based upon the current census data; and

WHEREAS, the Town Council has determined and concluded that it is advisable and necessary to redistrict the Town of Munster during the current year in order to comply with the applicable provisions of I.C. § 36-5-2-4.1, 36-5-2-5, and 3-11-1.5-32, as each are or have been amended from time to time, in order for the Town Districts (Wards) to be composed of contiguous territory, be reasonably compact, and contain (as nearly as possible) equal population; and

WHEREAS, the Town Council, having reviewed applicable State law and the current Town Districts (Wards) Ordinance No. 1578, now concurs that it is advisable, necessary, and in the best interests of the residents of the Town of Munster that amendments be made to the Town Districts (Wards) Ordinance to comply with applicable law;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MUNSTER, LAKE COUNTY, INDIANA, AS FOLLOWS:

SECTION ONE: That Town Ordinance No. 1578 be and the same is amended to read, add, and provide hereafter as follows, namely:

The Town of Munster shall be divided into the following districts (wards) for the purposes of conducting elections of Town Officials, to-wit:

DISTRICT (WARD) 1

(see attached legal description) - Exhibit A

DISTRICT (WARD) 2 (see attached legal description) – Exhibit B

DISTRICT (WARD) 3

(see attached legal description) – Exhibit C

DISTRICT (WARD) 4

(see attached legal description) - Exhibit D

DISTRICT (WARD) 5

(see attached legal description) – Exhibit E

Such described Ward District boundaries are shown on the map attached hereto as Exhibit "F", which map is made a part hereof and incorporated herein.

SECTION TWO: All existing Town Code Sections and Ordinances, or parts thereof, in conflict with the provisions of this Ordinance, are hereby deemed null, void, and of no legal effect, and are specifically repealed.

SECTION THREE: If any section, clause, provision, or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of competent jurisdiction, such decisions shall not affect any other section, clause, provision, or portion of this Ordinance.

SECTION FOUR: This Ordinance shall take effect January 1, 2023, pursuant to I.C. § 36-5-2-4.1, as amended, from and after its passage by the Town Council of the Town of Munster, Lake County, Indiana, and shall further be filed with the Clerk of the Lake County Circuit Court in conformance with applicable law.

EXHIBIT A

The boundary lines of Ward 1 of the Town shall be as follows:

Commencing at the northwest corner of the Town at the point on the Indiana/Illinois state line where such line intersects with the centerline of the Little Calumet River; then south along the Indiana/Illinois state line to the south corporate limits of the Town; then east along the south corporate limits of the Town to the centerline of the CSX Railroad right-of-way; then north along the centerline of the CSX Railroad right-of-way to its termination at the Northern Indiana Commuter Transportation District right-of-way; then north along the centerline of the Northern Indiana Commuter Transportation District right-of-way to the centerline of Fisher Street; then east along the centerline of Fisher Street to the centerline of Harrison Street; then north along the centerline of Harrison Street to the centerline of Evergreen Lane; then east along the centerline of Evergreen Lane to the centerline of Monroe Avenue; then north along the centerline of Monroe Avenue to the centerline of Briar Lane; then west along the centerline of Briar Lane to the centerline of Harrison Avenue; then north along the centerline of Harrison Avenue to the centerline of South Street; then northwesterly along the centerline of South Street to the centerline of the Northern Indiana Commuter Transportation District right-of-way; then north along the centerline of the Northern Indiana Commuter Transportation District right-of-way to the centerline of Ridge Road; then west along the centerline of Ridge Road to the centerline of Manor Avenue; then north along the centerline of Manor Avenue to the centerline of Hollywood Drive; then along the boundary line between Census Tract 403.02 Block 4007 and Census Tract 403.02 Block 1000 to its intersection with the boundary line between Census Tract 403.02 Block 4003 and Census Tract 403.02 Block 4004; then southeasterly along this line to its intersection with the centerline of the Little Calumet River: then northwesterly along the centerline of the Little Calumet River back to the place of its beginning.

Commencing at a point where the south corporate limits of the Town intersect the centerline of the CSX Railroad right-of-way; then north along the centerline of the CSX Railroad right-of-way to its termination at the Northern Indiana Commuter Transportation District right-of-way; then north along the centerline of the Northern Indiana Commuter Transportation District right-of-way to the centerline of Fisher Street; then east along the centerline of Fisher Street to the centerline of Harrison Avenue; then north along the centerline of Harrison Avenue to the centerline of Evergreen Lane; then east along the centerline of Evergreen Lane to the centerline of Monroe Avenue; then north along the centerline of Monroe Avenue to the centerline of Briar Lane; then west along the centerline of Briar Lane to the centerline of Harrison Avenue; then north along the centerline of Harrison Avenue to the centerline of South Street; then northwesterly along the centerline of South Street to the centerline of the Northern Indiana Commuter Transportation District right-of-way; then north along the centerline of the Northern Indiana Commuter Transportation District right-of-way to the centerline of Ridge Road; then west along the centerline of Ridge Road to the centerline of Manor Avenue; then north along the centerline of Manor Avenue to the centerline of Hollywood Drive; then along the boundary line between Census Tract 403.02 Block 4007 and Census Tract 403.02 Block 1000 to its intersection with the boundary line between Census Tract 403.02 Block 4003 and Census Tract 403.02 Block 4004; then southeasterly along this line to its intersection with the centerline of the Little Calumet River; then southeasterly along the centerline of the Little Calumet River to the point where it intersects the boundary line between Census Tract 404.01 Block 4001 and Census Tract 404.01 Block 4000; then southerly along an imaginary boundary line between Census Tract 404.01 Block 4001 and Census Tract 404.01 Block 4000 to the intersection of the centerline of Monaldi Drive and the centerline of River Drive; then northwesterly along the centerline of River Drive to the centerline of Tapper Drive; then south along the centerline of Tapper Drive to the centerline of Ridge Road; then southeasterly along the centerline of Ridge Road to the centerline of Columbia Avenue; then southwesterly along the centerline of Columbia Avenue to the centerline of Schoon Ditch; then east along the centerline of Schoon Ditch to its intersection with the northern extension of the centerline of Southwood Drive; then south along the centerline of Southwood Drive to the centerline of Tulip Lane; then east along the centerline of Tulip Lane to the centerline of Southwood Drive; then south along the centerline of Southwood Drive to the centerline of Oriole Drive, then west and southwesterly along the centerline of Oriole Drive to the centerline of Azalea Drive; then southeasterly along the centerline Azalea Drive to the centerline of Southwood Drive; then south along the centerline of Southwood Drive to the northern boundary of Census Tract 404.02 Block 1001; then northwesterly along the northern boundary of Census Tract 404.02 Block 1001 to its intersection with the centerline of Calumet Avenue; then south along the centerline of Calumet Avenue to the centerline of Columbia Avenue; then southwesterly along the centerline of Columbia Avenue to the south corporate limits of the Town; then west along the south corporate limits of the Town back to the place of its beginning.

Commencing at a point where the centerline of Columbia Avenue intersects with the centerline of the Little Calumet River; then westerly along the centerline of the Little Calumet River to the point where it intersects the boundary line between Census Tract 404.01 Block 4001 and Census Tract 404.01 Block 4000; then southerly along an imaginary boundary line between Census Tract 404.01 Block 4001 and Census Tract 404.01 Block 4000 to the intersection of the centerline of Monaldi Drive and the centerline of River Drive; then westerly along the centerline of River Drive to the centerline of Tapper Avenue; then southerly along the centerline of Tapper Avenue to the centerline of Ridge Road; then southeasterly along the centerline of Ridge Road to the centerline of Columbia Avenue; then southwesterly along the centerline of Columbia Avenue to the northern boundary of Census Tract 404.03 Block 3002; then east along the northern boundary of Census Tract 404.03 Block 3002 to its intersection with the boundary line of Census Tract 404.03 Block 3002 and Census Tract 404.03 Block 3001; then south along the boundary line of Census Tract 404.03 Block 3002 and Census Tract 404.03 Block 3001 to the intersection of the centerline of Elliott Drive and the centerline of Southwood Drive: then south along the centerline Southwood Drive to the centerline of Tulip Lane; then east along the centerline of Tulip Lane to the centerline of Southwood Drive; then south along the centerline of Southwood Drive to the centerline of Oriole Drive, then west and southwesterly along the centerline of Oriole Drive to the centerline of Azalea Drive; then southeasterly along the centerline Azalea Drive to the centerline of Dogwood Drive; then southerly along the centerline of Dogwood Drive to the centerline of Camellia Drive; then southeasterly along the centerline of Camellia Drive to its junction with White Oak Avenue; then southerly along the boundary of Census Tract 404.01 Block 2018 and Center Tract 404.03 Block 1023 to the centerline of 45th Street; then east along the centerline of 45th Street to the centerline of Hart Ditch (Plum Creek); then northeasterly along the centerline of Hart Ditch (Plum Creek) to the centerline of Fran-lin Parkway; then westerly along the centerline of Fran-lin Parkway to the centerline of Foliage Lane; then northeasterly along the centerline of Foliage Lane to the centerline of Inner Circle; then easterly to the centerline of Eat Delaware Parkway; then northeasterly along the centerline of East Delaware Parkway to the centerline of Washington Circle; then westerly along the centerline of Washington Circle to the centerline of Independence Drive; then westerly along the centerline of Independence Drive to the centerline of White Oak Avenue; then north along the centerline of White Oak Avenue to the centerline of Ridge Road; then northwesterly along the centerline of Ridge Road to the centerline of Greenwood Avenue; then north along the centerline of Greenwood Avenue and extending to its intersection with the Little Calumet River; then westerly along the centerline of the Little Calumet River back to the place of its beginning.


