### FINDINGS OF FACT APPROVING PRELIMINARY PLAT

Applicant is seeking to obtain approval of a Preliminary Plat for the Kenmara Phase 1B Dedication of Maple Leaf Boulevard.

The Public Hearing was opened. The Public Hearing was closed. Based upon the testimony and evidence presented, having given due consideration and having paid reasonable regard to the requirements of the Subdivision Control Ordinance of the Town of Munster as amended from time to time, as well as Indiana State law, upon motion duly made and seconded and by a vote of five (5) in favor and zero (0) opposed, the Munster Plan Commission approves the Applicant's Preliminary Subdivision Plat.

In making such determination, the Town of Munster Plan Commission makes the following written Findings of Fact pursuant to Indiana Code, I.C. 36-7-4-707, as amended from time to time.

1. The proposed Plat is consistent with the comprehensive plan for the orderly development of the Town of Munster and promotes the general welfare of the Town of Munster.
2. The proposed Plat does provide for adequate ingress and egress to the subdivision.
3. The proposed Subdivision will have a positive effect on neighboring properties and is consistent with the Master Plan.
4. The approval is subject to the following conditions:
  - A. Submittal of a revised public landscaping plan meeting Town codes and standards.
  - B. Submittal of a landscaping plan for park areas meeting the approval of the Munster Park Board.
  - C. Submittal of a public lighting plan meeting Town codes and standards.
  - D. Final Town engineer approval of all engineering plans to ensure (1) compliance with all Town codes and standards, (2) the relocation of the Pennsy Greenway trail crossing to the north side of the Pepsi driveway, unless shown to be infeasible, and (3) the inclusion of a raised crossing of the Pennsy Greenway trail at Fisher Street.

- E. All necessary easements, agreements, and approvals both by the Town and third parties have been made and approved for the completion of Phase 1A and Phase 1B, as shown on the development plans, providing access to the Kenmara Addition from Fisher Street and Maple Leaf Crossing to the satisfaction of the Town of Munster Plan Commission.

WHEREFORE, based upon the above Findings of Fact, the Munster Plan Commission approves the Preliminary Plat of the Applicant.
