



HOW NIPSCO RESTORES POWER

• First repair high voltage transmissions lines and substations (and re-route power where possible), which provide power to the largest number of customers. Without repairing this part of the system first, the smaller electric lines connected to homes and business can't be energized.

- Next, the process shifts to restoring power to facilities most critical to pubic safety and health, including hospitals, police and fire stations, water lift stations and communications systems.
- NIPSCO crews are disbursed to repair service lines that will bring back power to the largest amount of customers the quickest - including major lines that feed power to densely populated neighborhoods and other rural/municipal electric companies.
- Last repairs are made to electric service affecting smaller neighborhoods or outages that impact one or two individual customers.

TREES AND YOUR POWER

- Trees are the leading cause of power outages! Storms can cause tree limbs to break, and trees can fall, pulling down power lines. Don't touch any sagging or downed power lines. Call NIPSCO at 1-800-4-NIPSCO/911 to report the downed line immediately.
- Don't trim or remove trees that are near power lines. Call NIPSCO if you see a tree that could cause a downed power line or power outage.
- Select the right tree consider the height, spread and placement to avoid future contact with power lines. A list of tree contractors certified and insured are listed on NIPSCO's website https://www.nipsco.com.

PREPARE FOR AN OUTAGE

- Monitor the weather forecast.
- If severe weather calls for a tornado, pick a safe place where everyone can gather. This location can be your basement, or a center hallway, bathroom, or closet on the lowest floor.
- Compile a storm preparedness kit, including essential medicines, non-perishable food items and water, flashlights, portable radios, extra batteries etc.
- Make prior arrangements if someone requires life support equipment, make prior arrangements for back-up supply.

Committee. And, what is a Complete Count Committee?

A Complete Count Committee is a group of leaders representing a cross-section of our community who can find creative ways to make sure everyone who should be counted is counted in the Census. A Complete Count Committee is a group of individuals that will work together to build awareness and enthusiasm to participate in the Census, relying in part on their knowledge of the local community and in part on their ability to engage trusted voices.

And, why is a complete count important? Federal and state funding is allocated to communities, and decisions are made on matters of national and local importance based, in part, on census data and housing. Census data helps determine how many seats each state will have in the U.S. House of Representatives and is necessary for the accurate and fair redistricting of state legislative seats, county and town councils, and voting districts. Information from the 2020 Census and American Community Survey are vital tools for economic development and increased employment.

Why We Conduct the Decennial Census

- A census aims to count the entire population of a country, and at the location where each person usually lives.
- Questions asked of people in homes and group living situations, including how many people live or stay in each home, sex, age, and race of each person. The goal is to count everyone once, only once, and in the right place.

How the Census Benefits Your Community

- Federal funds, grants and support to states, counties, and communities are based on population totals and breakdowns by sex, age, race, and other factors. Each community benefits the most when the census counts everyone.
- Businesses use census data to decide where to build factories, offices, and stores, and this creates jobs.
- Developers also use the census to build new homes and revitalize neighborhoods.
- Local governments use census for public safety and emergency preparedness.

Importance of Apportionment

- Article I, Section 2 of the U.S. Constitution mandates that an apportionment of representatives among the states must be carried out every 10 years. Therefore, apportionment is the original legal purpose of the decennial census, as intended by our Nation's Founders.
- Apportionment is the process of dividing the 435 memberships, or seats, in the U.S. House of Representatives among the 50 states, based on the state population counts that result from each decennial census.
- These apportionment results will be the first data published from the 2020 Census, and these results will determine the number of seats each state will have in the U.S. House of Representatives for the next 10 years.

IMPORTANT!!

- Census Bureau is expected to announce the new population counts by Dec. 31, 2020.
- Numbers are sent to President of the United States for the reapportionment of congressional seats, which goes into effect beginning with 2022 elections.
- 2020 Census data used for state and local redistricting are set to be released by March 31, 2021.

The Town will pick up white goods on Wednesdays.
