### CLERK TREASURER

August is Back to School Month, and we know that education will look much different this fall than it has in the past. Many Munster families are

figuring out how the new school year will work. Others are figuring out how to avoid the increased traffic in school zones.

While the children of our community return to school, we know that education is something we never outgrow and many of us have continuing education requirements associated with our work. Town of Munster employees are no exception.

The Munster Police Department is mandated by State code to have in-service education on a variety of topics, which include human trafficking, mental illnesses, and addictions. They have training for handling firearms, physical tactics, and vehicle operation. Our officers get far more than the State-mandated training required to acquire and retain their specialized skills. To maintain our gold standard CALEA accreditation, our officers must complete additional training on ethics, bias policing, diversity, de-escalation, pursuit, and the use of force.

The members of our Munster Fire Department train weekly and have monthly online training. Fire Department officers have even more training requirements. Elective training for specialized firefighting techniques helps prepare our firefighters for any emergency.

The Parks Department attend sessions to learn upcoming trends and best practices. Community Development stays up to date with State building codes, and Public Works is committed to ongoing education, seminars, and workshops. Even the 2020 newly elected Town officials attended training in January with sessions specific to their position in towns our size as well as ethics, budgets, and Open-Door Laws.

The Clerk-Treasurer is required by Indiana Code IC 36-5-6-10 to complete 14 hours of training within one year and 36 hours of instruction within three years. Road funding, building and maintaining budgets, ethics, TIF, and the nuts and bolts of being a Clerk-Treasurer were among the topics covered this past March at Ball State University in Muncie.

The information provided at these sessions helps to keep us current on state finance changes, offers strategies to improve our administrative techniques, and helps us to be compliant with the many rules we are mandated to adhere to while protecting the assets of the Town.

The workshops and training are long days filled with lots of information. The more I attend, the more I understand what is applicable and beneficial to our Town. I received my ICMA certification in 2020 and I will be able to take higher level classes in the future. The meetings provide opportunities to forge relationships with my peers throughout the state and I find them to be helpful resources. In addition, I will be returning to IUN for one of my final semesters as I pursue a master's degree in Public Affairs.

We know that education will look much different this fall than in years past, but we also know that continually learning improves our ability to perform our jobs efficiently and knowledgeably.

## Help Us Find You! Can We See Your Address?

Every home in Munster needs to have address numbers posted facing the addressed street. Address numbers should be at least 4” tall, 1/2” wide with a contrasting color to its background. If you have a home that has an alleyway, address numbers must be posted on the rear facing the alley. See Munster Ordinance 26-2 & IFC 505.0. A clearly labeled address enables Emergency Responders to locate you as quickly as possible.

### Munster Ordinance 26-2 & IFC 505.0 Building Numbering

- (A) Every building and structure within the town shall bear a number to designate its location and address upon the street or property on which it fronts.
- (B) The number shall be that designated and determined by the building inspector of the town, and the number shall be determined and given to the owner upon issuance of a building permit.
- (C) The number constituting the address and location shall be in accordance with the following standards.
  - (1) Arab numerals shall be used.
  - (2) Each numeral shall be such a size that it is readily visible from the street.
  - (3) Each numeral shall be raised and clearly visible by line of sight from the abutting street or thoroughfare.
  - (4) The number shall be in a contrasting color that of its background, i.e., and a black number on a light-colored background or a white number on a dark-colored background.
  - (5) The number shall be at or about the main entrance of the building or structure.
  - (6) Where required by the *fire code official*, address numbers shall be provided in additional *approved* locations to facilitate emergency response.
  - (7) Where access is by means of a private road and the building cannot be viewed from the public way, a monument, pole, or other sign or means shall be used to identify the structure.
- (D) At such as a building or structure is under roof, a temporary number shall be displayed. At or prior to the issuance of an occupancy permit, the permanent numbers shall be displayed.

### BACK TO SCHOOL SAFETY TIPS FROM THE MUNSTER POLICE DEPARTMENT

Munster schools start back again this August. Parents and other residents are asked to read through these tips to help promote safety for children in the areas of our schools.

- Motorists are reminded that the speed limit in school zones is 20 mph. Police officers and school resource officers are often stationed in the areas of the schools to enforce violations of traffic laws and to provide police presence.
- Motorists are encouraged to be alert in school zones for children crossing the street or who are walking in between vehicles or through parking lots.
- Please remember that vehicles must yield to pedestrians at marked crosswalks at all times, so please go slowly in the school zones and be ready to stop safely at any time.
- Also remember that Indiana is now completely hands-free, so drivers should not be holding phones to talk or text while operating a vehicle unless they are calling 911. Motorists are encouraged to stay off of your phones (even hands free) while in school zones so that you can pay extra attention to people and other vehicles that are around you.
- Parents are asked to follow the pick-up and drop-off procedures that were provided by your school. Be a good role model for your children by following the rules and treating school staff members or parking lot volunteers with respect.
- Parents should report ongoing safety issues or concerns, including bullying, to school officials immediately. You can also request that one of our school resource officers are involved when necessary.
- Discuss stranger-danger with your children and teenagers, especially if they walk/bike to or from school. If possible and for their safety, never allow small children to walk to school alone. Walk or drive them there if you can.
- Talk with your children and teenagers about bullying and encourage them to report any issues to you or school staff members right away so that the situation can be taken care of. Always report suspicious individuals or vehicles that are located around the schools immediately to the police department by calling 911.

Munster Pool is open each day until August 11th. After 8/11, the pool moves to limited dates/hours. Check social media for updates as information is ever-changing.



## Bonfires & Open Burning

Let's talk about bonfires or open burning. Burning is prohibited in apartment and condominium complexes. Burning must be in a non-combustible container that is sufficiently vented and has enclosed sides and bottoms. Only clean wood can be burned. You cannot burn painted wood, garbage, plastic, tires, etc. If a fire creates a nuisance, fire hazard or pollution problem, the Fire Department will be notified and the fire will be extinguished. Please keep in mind if there are unfavorable conditions such as high winds, air stagnation or when a pollution alert or ozone action day has been declared, you should not attempt to ignite or maintain a bonfire. Following this simple guidelines will keep you and your neighborhood safe.
