

AMENDMENT NO: 03
TO AGREEMENT
BETWEEN
OWNER AND ENGINEER
CDM SMITH PROJECT NUMBER 267659

This Amendment Number 03 is made and entered on January 1, 2023 and amends the terms and conditions of the Agreement between CDM Smith Inc. ("CDM Smith" or "ENGINEER") and Munster, Indiana ("OWNER"), dated January 1, 2023 ("the Agreement").

WHEREAS, ENGINEER and OWNER entered into the Agreement for the the review of based designs of the Munster Dyer and Munster Rigid train stations prepared by the Joint Venture for NICTD and to assist the Town of Munster develop a list of station betterment requests to the base designs.; and

WHEREAS, the parties desire to amend the Agreement so as to amend the scope of work, time periods of performance and payment, and/or responsibilities of OWNER; and

WHEREAS, the Agreement provides that any amendments shall be valid only when expressed in writing and signed by the parties.

NOW THEREFORE, in consideration of the mutual understandings and Agreements contained herein, the parties agree to amend the Agreement as follows:

1. The Basic Services of ENGINEER as described in the Agreement are amended and supplemented as follows:
 - 1.1 There are no changes to the Basic Services of the ENGINEER as described in the Agreement.
2. The responsibilities of OWNER as described in the Agreement are amended and supplemented as follows:
 - 2.1 There are no changes to the Basic Services of the OWNER as described in the Agreement.

3. The time periods for the performance of ENGINEER's services as set forth in the Agreement are amended and supplemented as follows:

3.1 Extend the Contract completion date from December 31, 2022 to December 31, 2023.

4. The payment for services rendered by ENGINEER shall be as set forth below:

4.1 There are no changes to the payment for services. This is a zero-cost change.

4.2 The hourly bill rates in Section 4.0 of the "Agreement" have been escalated 3% per year from calendar year 2021 to calendar year 2023. The 2023 hourly billing rates are as follows:
